231 dogs and cats were placed in forever homes

485 community dog and cats spay/neutered

354 community (feral) cats spay/neutered and provided more than 16,640 lbs. of food for them

2018 through 2019 Accomplishments

We replaced our old website with a state of the art website. We rewrote and added new content, changed how information is organized, and instituted a less expensive on-line payment system. Check it out at moabpets.org.

We increased the rate of pet adoptions and decreased the time animals are at Shelter. We applied for, and received a Colorado Department of Agriculture Pet Animal Facilities Act (PACFA) permit so that we can transport cats to adoption days at Petco in Grand Junction, Colorado. Volunteers transport animals to Petco where they are adopted so very much faster than in Moab. We are grateful to our Grand Junction Petco partner!

We improved the working cat colony "facilities" at the Grand County Old Spanish Trail Arena. The working cats transported here are not adoptable, so they earn their keep by catching mice in the barns at the arena. We bought them their very own 10' x 12' barn and worked with Arena staff and volunteers to set it up to be safe and cozy. The barn is complete with sleeping nooks and crannies, scratching posts, and soft beds! We also improved the existing covered cat enclosures where new cats are held for two weeks so that they bond to the arena location.

We expanded life-saving services for dogs and cats in Green River and La Sal. We held our first partially-subsidized spay/neuter clinics in Green River and La Sal. We expanded our adoption program to accept homeless pets in Green River with the help of area foster volunteers. We assisted with spay/neuter of a feral cat colony at Green River State Park to make sure the all cats there were sterilized. We instituted a new Trap Neuter Return program in Green River.

We partnered with local organizations to help our community animals: Wabi Sabi Nonprofit partner, Red Rock 4 Wheelers, Synergy Company, Moonflower Market, Moab Trail Marathon, and BEACON Lights On! Program.

We increased our visibility and outreach. Volunteers sold t-shirts and dog neck bandanas at Jeep Safari and Walker Drug during Jeep Safari week. We decorated our float and joined the Moab holiday Electric Light Parade in 2018 and 2019. We presented a slide show to Travel Council Board as well as developed new educational flyers.

We increased our organizational capacity and capability. We revised administrative policies. We developed and adopted a strategic plan. We attended training and worked hard to earn two additional Utah Nonprofit Organization Credential Badges. We continue to have 30 active volunteers who are indispensable to help us keep things running smoothly.

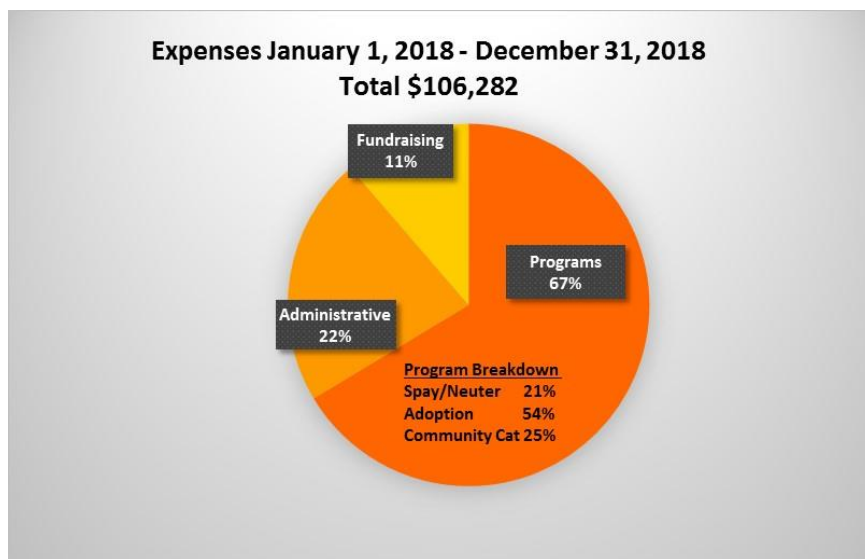
